"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville.

All that certain piece, parcel or lot of land situate lying and being in the County of Greenville, State of South Carolina, being known and designated as Lot #66, on Bromsgrove Drive, as recorded in Plat Book 4N, at pages 2,3 and 4, in the Office of the R.M.C., for Greenville County, reference being made to said Plat for a more detailed description.
