MORTGAGE

TO ALL WHOM THESE PRESENTS MAY CONCERN:

Leonard H. Reece, Jr. (hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto Liberty Corporation Credit Union (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of

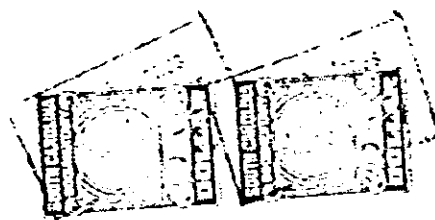
Five Thousand and no/100-374~~EN~~ OF 17~~TH~~ per month on the unpaid balance of \$5,000.00, with interest thereon from date at the rate of 17 per centum per annum, said principal and interest to be repaid: \$159.00 per month including principal and interest computed at the rate of 3/4th of 1% per month on the unpaid balance, the first payment being due June 30, 1973 and a like payment due on the last day of each month thereafter for a total of 36 months.

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purposes:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns: "All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, situate on the northeastern side of Sylvania Drive, being shown as lot no. 14 on a plat of Dogwood Terrace dated May, 1960, prepared by J. Mac Richardson, recorded in Plat Book UU at Page 5 in the R.M.C. Office for Greenville County and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northeastern side of Sylvania Drive at the joint front corner of lot 14 and lot 16 and running thence with lot 16 N. 56-48 E. 149.4 feet to an iron pin at the joint rear corner of lot 14 and lot 16; thence with lot 15 and lot 13 N. 33-02 W. 100 feet to an iron pin at the joint rear corner of lot 12 and lot 14; thence with lot 12 S. 56-48 W. 148.9 feet to an iron pin on the northeastern side of Sylvania Drive; thence with said Drive S. 32-42 E. 100 feet to the point of beginning.

This is the same property conveyed to the mortgagor by deed recorded in Deed Book 681 at Page 499 in the R.M.C. Office for Greenville County.
