Frances B. Faulkenberry (hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto GREER FEDERAL SAVINGS AND LOAN ASSOCIATION, GREER, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of Fifteen Thousand and no/100

DOLLARS (\$ 15,000.00), with interest thereon from date at the rate of seven & three-fourths per centum per annum, said principal and interest to be repaid as therein stated, and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purpose;

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville on the western side of Cunningham Road containing five (5) acres, more or less, and being shown on a plat entitled "Property of W. L. Cunningham" recorded in the R.M.C. Office for Greenville County in Plat Book UUU at page 53 and having, according to said plat, the following metes and bounds, to-wit:

Beginning at an iron pin on the western side of Cunningham Road, common corner of the within described property and that now or formerly of Griffin Cunningham and running thence N. 85-02 W. 432.2 feet to a point; thence N. 3-02 W. 500 feet to a point; thence S. 85-02 E. 432 feet, more or less, to a point on the western side of Cunningham Road; thence with said road S. 3-02 E. 500 feet, more or less, to the point of beginning.

This is the identical property conveyed to the mortgagors herein by deed recorded in the R.M.C. Office for Greenville County in Deed Book 937, page 30.

This is a second mortgage on the above described property and is junior in lien to that first mortgage given by the mortgagors herein to Greer Federal Savings & Loan Association in the original amount of \$35,000.00 recorded in the R.M.C. Office for Greenville County in Mortgage Book 1223, page 305.
