"All that certain piece, parcel or lot of Lnd, with all improvements thereon, or bereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Greenville County, Fairview Township, as shown on a Plat for the Small Business Administration, prepared by Webb Surveying and Mapping Company in May, 1971 and revised in June, 1973 and being more fully described in said Plat as follows:

BEGINNING at an iron pin on the Northeastern side of Neely Ferry Road at the joint corner of land now or heretofore owned by the Grantors and running thence N. 14-50 E. 300 feet to an iron pin; thence N. 62-10 E. 1,960.2 feet to an iron pin, said iron pin located on the Northeastern side of a small stream; thence N. 67-21 W. 267 feet to an iron pin; thence N. 50-51 W. 185 feet to an iron pin; thence S. 64-17 W. 267.2 feet to an iron pin; thence S. 39-28 W. 761 feet to an iron pin at a Poplar Tree; thence S. 14-50 W. 1,245 feet to an iron pin on the Northeastern side of Neely Ferry Road; thence S. 40-46 E. 59.9 feet to an iron pin at the beginning point.
