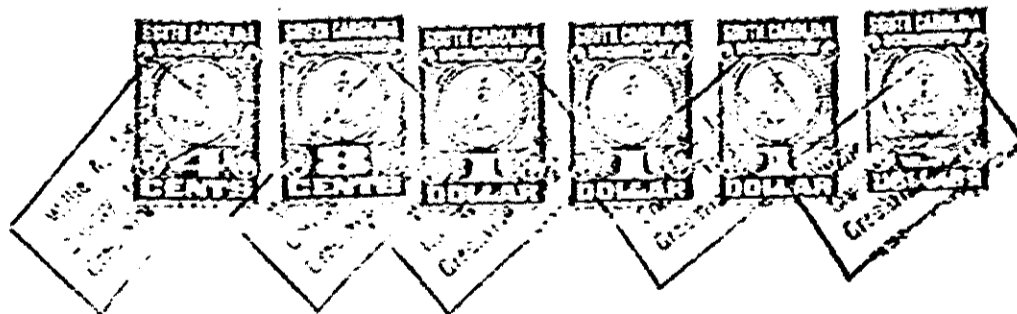

10/100-----Dollars (\$ 20,250.00), with interest from date at the rate of
seven & three/fourths per centum (73/4%) per annum until paid, said principal and interest being payable
at the office of C. DOUGLAS WILSON & CO.
in Greenville, South Carolina, or at such other place as the holder of the note may
designate in writing delivered or mailed to the Mortgagor, in monthly installments of One Hundred Forty-
Five and 19/100-----Dollars (\$ 145.19), commencing on the first day of
October, 1973, and continuing on the first day of each month thereafter until the principal and
