TO ALL WHOM THESE PRESENTS MAY CONCERN: we, Robert E. Turner and Alice M. Turner

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

All that certain piece, parcel or lot of land, with all improvements thereon, or to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the South side of Memorial Drive Extension about three miles Northwest of Greer, in Oneal Township, and being known and designated as Lot No. Five (5) of the Valleyhaven property of W. Dennis Smith as shown on plat prepared by H. S. Brockman and John A. Simmons, Reg. Surveyors, dated July 22, 1959 and which plat has been recorded in the R. M. C. Office for said County in Plat Book TT, page 11. This being the same property which was conveyed to mortgagors herein by W.
