organized and existing under the laws of South Carolina, hereinafter called Mortgagee, as evidenced by a certain promissory note of even date herewith, the terms of which are incorporated herein by reference, in the principal sum of Twenty-nine Thousand Three Hundred and no/100-----Dollars (\$29,300.00), with interest from date at the rate of seven and 3/4ths per centum (7 3/4%) per annum until paid, said principal and interest being payable at the office of C. Douglas Wilson & Co. in Greenville, South Carolina, or at such other place as the holder of the note may designate in writing delivered or mailed to the Mortgagor, in monthly installments of Two Hundred Ten and 08/100-----Dollars (\$210.08), commencing on the first day of October, 1973, and continuing on the first day of each month thereafter until the principal and interest are fully paid, except that the final payment of principal and interest, if not sooner paid, shall be due and payable on the first day of September, 2003.

Now, KNOW ALL MEN, that Mortgagor, in consideration of the aforesaid debt and for better securing the payment thereof to the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, assigned, and released, and by these presents does grant, bargain, sell, assign, and release unto the Mortgagee, its successors and assigns, the following-described property situated in the county of Greenville State of South Carolina;

ALL that piece, parcel or lot of land, situate, lying and being in the State of South Carolina, County of Greenville, and being shown and designated as Lot 18 on plat entitled Coral Ridge Subdivision, recorded in Plat Book XX at page 119 in the R.M.C. Office for Greenville, South Carolina, and according to said plat having the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Eastern side of Coral Drive and running thence with Coral Drive N. 3-50 E. 90 feet to an iron pin; thence S. 86-10 E. 165 feet to an iron pin; thence S. 0-34 W. 87.6 feet to an iron pin; thence N. 87-0 W. 170 feet to the point of beginning.

"The following items are hereby acknowledged as part of the mortgaged property: Range or Counter Top Unit, Dishwasher, Wall to Wall Carpeting, Porch, Fence."
