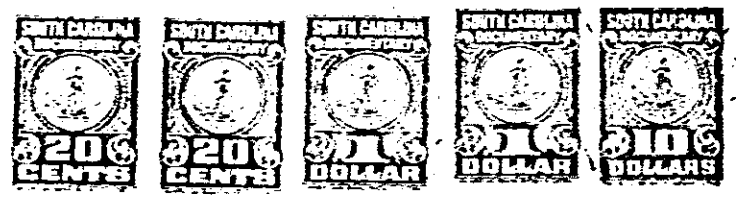

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of the e presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, about eight miles north of Greer and four miles south of Gowansville, being on the northwestern side of S. C. Highway No. 14, containing 4.1 acres, more or less, and being a portion of that property as shown on a survey for Harold Smith dated January 28, 1972, by W. N. Willis, Engineers, and recorded in Plat Book SSS at pages 510 through 512, R.M.C. Office for Greenville County, and having the following netes and bounds to-wit:

BEGINNING at an iron pin on the northwest side of S.C. Highway No. 14 and running thence N. 49-20 W. 482.5 feet to an iron pin; thence N. 87-30 W. 254 feet to an iron pin; thence N. 35-00 E. 369 feet to an iron pin; thence S. 49-00 E. 715 feet to an iron pin on S.C. Highway No. 14; thence with northwestern side of S.C. Highway No. 14, S. 38-45 W. 193 feet to the point of beginning.
