For and in consideration of the sum of One Dollar (\$1.00), and other good and valuable consideration, to it in hand paid at or before the signing, sealing and delivery of these presents, receipt of which is hereby acknowledged, Blue Ridge PRODUCTION CREDIT ASSOCIATION, a corporation, the owner and holder of a certain mortgage, executed by Thomas G. Sloan and Ruth K. Sloan to it, on January 28, 1972, recorded in Mortgage Book 1220, page 577, public records of Greenville County, South Carolina, does hereby release and relinquish the lien of said mortgage insofar, and so far only, as the same covers and embraces the following described property:

ALL that lot of land located in the State of South Carolina, County of Greenville, about one mile south of the Old Jordan High School and about eight miles North of Greer, Highland Township, on the west side of S.C. Hwy. #277, containing 16.8 acres, more or less, as shown on a survey for Thomas G. Sloan dated June 4, 1973, by W. N. Willis, Engineers, to be recorded herewith, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at a nail in the center of S.C. Hwy. #277 and running thence S. 61-00 W. 25 ft. to an iron pin on western edge of said highway; thence S. 61-00 W. for a total distance of 1,890 ft. to an iron pin; thence N. 26 E. 59 ft. to an iron pin; thence due North 660 ft. to an old iron pin; thence N. 74-08 E. 912 ft. to an iron pin; thence N. 71-25 E. 595 ft. to a nail in the center of S.C. Hwy. #277; thence along and with said Hwy. S. 39-38 E. 280 ft. to the point of beginning.
