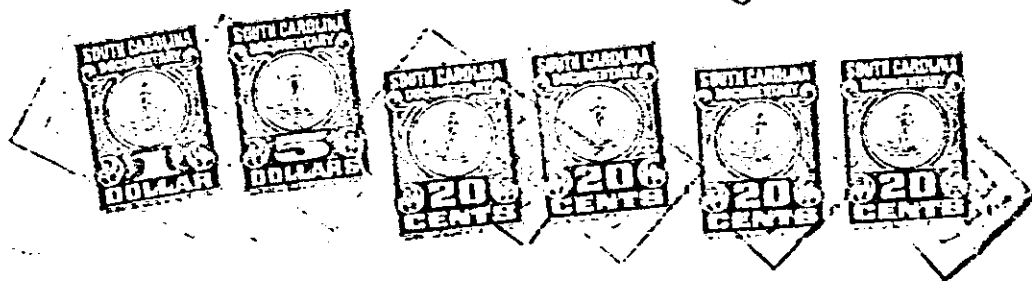
WHEREAS:

KIRK D. NASON of  
Greenville County, South Carolina, hereinafter called the Mortgagor, is indebted to  
CAROLINA NATIONAL MORTGAGE INVESTMENT CO., INC. , a corporation

organized and existing under the laws of the State of South Carolina, hereinafter  
called Mortgagee, as evidenced by a certain promissory note of even date herewith, the terms of which are incor-  
porated herein by reference, in the principal sum of Seventeen Thousand and No/100-----  
Dollars (\$ 17,000.00 ), with interest from date at the rate of  
eight & one-half per centum (8½ %) per annum until paid, said principal and interest being payable  
at the office of Carolina National Mortgage Investment Co., Inc., P. O. Box 935  
in Charleston, South Carolina, or at such other place as the holder of the note may  
designate in writing delivered or mailed to the Mortgagor, in monthly installments of One Hundred Thirty  
and 73/100-----Dollars (\$ 130.73 ), commencing on the first day of  
November, 1973, and continuing on the first day of each month thereafter until the principal and  
interest are fully paid, except that the final payment of principal and interest, if not sooner paid, shall be due and  
payable on the first day of October, 2003.

Now, Know ALL MEN, that Mortgagor, in consideration of the aforesaid debt and for better securing the  
payment thereof to the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3) to the Mortgagor  
in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt  
whereof is hereby acknowledged, has granted, bargained, sold, assigned, and released, and by these presents does  
grant, bargain, sell, assign, and release unto the Mortgagee, its successors and assigns, the following-described  
property situated in the county of Greenville  
State of South Carolina;

ALL that certain piece, parcel or lot of land, together with improvements  
thereon, situate, lying and being on the Northern side of Waters Avenue  
in the City of Greenville, County of Greenville, State of South Carolina,  
being known and designated as Lot No. 2 as shown on a Plat entitled  
PICKWICK HEIGHTS, dated March, 1950, prepared by Dalton & Neves Engineers,  
and recorded in the RMC Office for Greenville County, S. C., in Plat Book  
"X", Page 141, and being further shown and designated on a more recent  
plat entitled "Property of Kirk D. Nason", dated August 31, 1973, pre-  
pared by Carolina Engineering & Surveying Company and recorded in the  
RMC Office for Greenville County, S. C., in Plat Book 5C, Page 5/  
reference to which is hereby craved for the metes and bounds description  
thereof.
