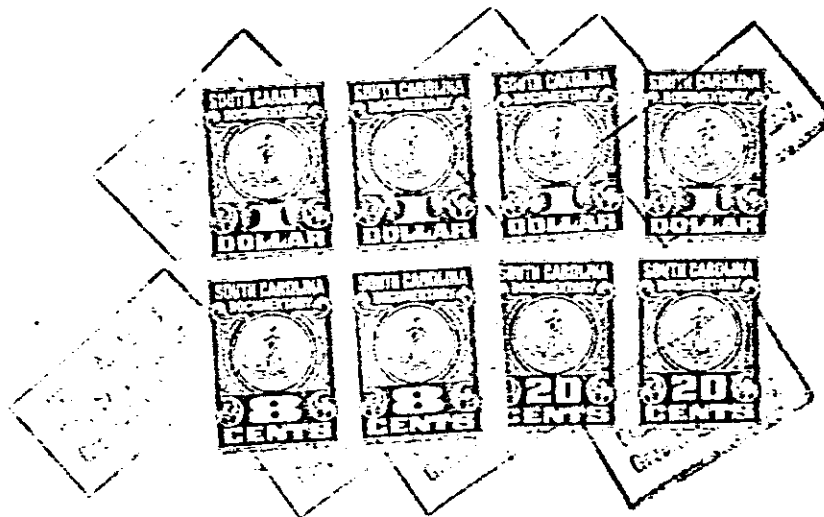

WHEREAS:

Isaac Atkins and Julia G. Atkins  
Greenville County, South Carolina , hereinafter called the Mortgagor, is indebted to

CAROLINA NATIONAL MORTGAGE INVESTMENT CO., INC. , a corporation  
organized and existing under the laws of the State of South Carolina , hereinafter  
called Mortgagee, as evidenced by a certain promissory note of even date herewith, the terms of which are incor-  
porated herein by reference, in the principal sum of Eleven Thousand Three Hundred Fifty and  
no/100ths-----Dollars (\$ 11,350.00 ), with interest from date at the rate of  
eight and one-half per centum ( 8½ %) per annum until paid, said principal and interest being payable  
at the office of Carolina National Mortgage Investment Co., Inc., Post Office Box 935  
in Charleston, South Carolina, 29402 , or at such other place as the holder of the note may  
designate in writing delivered or mailed to the Mortgagor, in monthly installments of Eighty Seven and  
28/100ths-----Dollars (\$ 87.28 ), commencing on the first day of  
November , 1973 , and continuing on the first day of each month thereafter until the principal and  
interest are fully paid, except that the final payment of principal and interest, if not sooner paid, shall be due and  
payable on the first day of October , 2003.

Now, KNOW ALL MEN, that Mortgagor, in consideration of the aforesaid debt and for better securing the  
payment thereof to the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3) to the Mortgagor  
in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt  
whereof is hereby acknowledged, has granted, bargained, sold, assigned, and released, and by these presents does  
grant, bargain, sell, assign, and release unto the Mortgagee, its successors and assigns, the following-described  
property situated in the county of Greenville, in the City of Greenville  
State of South Carolina; on the southern side of DeOyley Avenue, being known and designated  
as Lot No. 24, as shown on plat entitled AUGUSTA ROAD RANCHES, dated April, 1941, and  
revised April, 1942, prepared by Dalton & Neves, and recorded in the R. M. C. Office  
for Greenville County, South Carolina, in Plat Book "M" at Page 47. Said Lot fronts  
60 feet on the southern side of DeOyley Avenue and runs back in parallel lines to a  
depth of 200 feet, and is 60 feet across the rear.



Together with all and singular the improvements thereon and the rights, members, hereditaments, and appurtenances  
to the same belonging or in anywise appertaining; all the rents, issues, and profits thereof (provided, however, that  
the Mortgagor shall be entitled to collect and retain the said rents, issues, and profits until default hereunder); all  
fixtures now or hereafter attached to or used in connection with the premises herein described and in addition thereto  
the following described household appliances, which are and shall be deemed to be, fixtures and a part of the realty  
and are a portion of the security for the indebtedness herein mentioned;
