WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of Ten thousand eight hundred seventy-five and no/100ths----- DOLLARS

(\$ 10,875.00), as evidenced by the Mortgagor's note of even date, bearing interest as stated in said note, and payable as therein stated or as modified by mutual agreement, in writing, the final maturity of which is five (5) years after the date hereof, unless extended by mutual consent, the terms of said note and any agreement modifying it are incorporated herein by reference; and

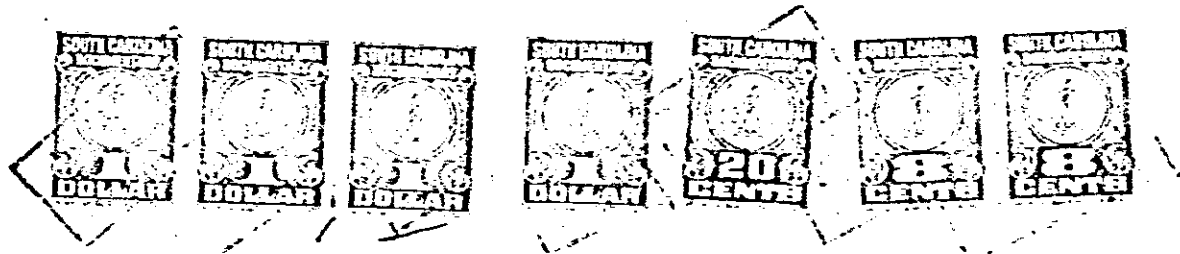
WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced or readvanced to or for the Mortgagor's account, including advances made by the Mortgagee on other or no security:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

*All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the southwestern side of the cul-de-sac of Old Town Way, being shown and designated as Lot No. 30 on a plat of Holly Tree Plantation, made by Ewright Associates, Inc., Engineers, dated May 28, 1973, recorded in the RMC Office for Greenville County in Plat Book 4x, pages 32 through 37, inclusive and having the following metes and bounds, to-wit:

BEGINNING at an iron pin on the western side of the cul-de-sac of Old Town Way at the joint front corner of Lots 29 and 30 as shown on the aforesaid plat and running thence along and with the joint property line of said Lots, S 71-40 W 176.23 feet to an iron pin; thence S 22-01-29 E 132.58 feet to an iron pin; thence S 87-25 E 120.32 feet to an iron pin at the joint rear corner of Lots 30 and 31; thence running along and with the joint property line of said Lots, N 21-42 E 154.46 feet to an iron pin on the western side of the cul-de-sac of Old Town Way; thence with said cul-de-sac, the chord of which is N 59-03-30 E 51.54 feet to the beginning point.
