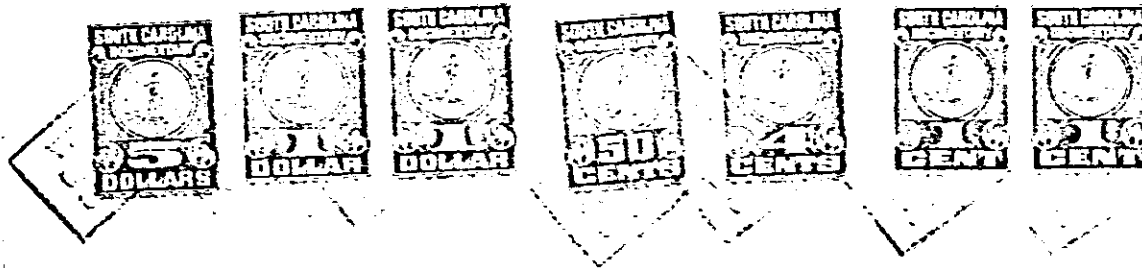
WHEREAS:

William A. Robinson and Annie S. Robinson of
Greenville, South Carolina, hereinafter called the Mortgagor, is indebted to

Wachovia Mortgage Company, Winston-Salem, N. C., a corporation
organized and existing under the laws of North Carolina, hereinafter
called Mortgagee, as evidenced by a certain promissory note of even date herewith, the terms of which are incor-
porated herein by reference, in the principal sum of Eighteen Thousand, Nine Hundred and No/100
Dollars (\$ 18,900.00), with interest from date at the rate of
eight and one-half per centum (8-1/2%) per annum until paid, said principal and interest being payable
at the office of Wachovia Mortgage Company
in Winston-Salem, N. C., or at such other place as the holder of the note may
designate in writing delivered or mailed to the Mortgagor, in monthly installments of One Hundred Forty-
Five and 34/100 Dollars (\$ 145.34), commencing on the first day of
November, 1973, and continuing on the first day of each month thereafter until the principal and
interest are fully paid, except that the final payment of principal and interest, if not sooner paid, shall be due and
payable on the first day of October, 2003.

in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt
whereof is hereby acknowledged, has granted, bargained, sold, assigned, and released, and by these presents does
grant, bargain, sell, assign, and release unto the Mortgagee, its successors and assigns, the following-described
property situated in the county of Greenville,
State of South Carolina;

in the State of South Carolina, County of Greenville, being known and designated
as Lot No. 46 of a subdivision known as Sylvan Hills as shown on plat thereof
