

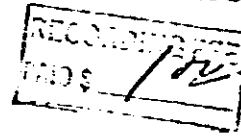

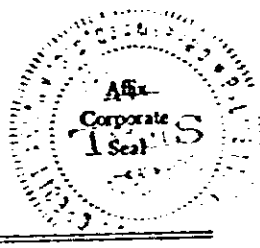

For and in consideration of the sum of One Dollar (\$1.00), and other good and valuable consideration, to it in hand paid at or before the signing, sealing and delivery of these presents, receipt of which is hereby acknowledged, PALMETTO PRODUCTION CREDIT ASSOCIATION, a corporation, the owner and holder of a certain mortgage, executed by Dr. R. Brooks Scurry and Dr. Jack C. Scurry to it, on August 23, 1972, recorded in Mortgage Book 1246, page 155, public records of Greenville County, South Carolina, does hereby release and relinquish the lien of said mortgage insofar, and so far only, as the same covers and embraces the following described property: All of that certain piece, parcel or tract of land, situate, lying and being in the Grove Township in the County of Greenville and State of South Carolina, containing 81.45 acres, more or less, and being designated as Tract No. 2 on a plat entitled, "Property of John C. Scurry and Ralph Brooks Scurry", made by Hearst Coleman & Associates, Engineers, Greenwood, S. C., dated September 5, 1972, and recorded in the RMC Office for Greenville County, S. C., in Plat Book , at Page . According to said plat, Tract No. 2 is bounded: On the North by a branch and property now or formerly of W.R. Bowling and Scott; on the East by Reedy Fork Creek; on the South by property now or formerly of S.B. Huff and property now or formerly of J.T. Scott; and on the West by a dirt road and property now or formerly of Scott, and has such shape, metes, courses and distances as will more fully appear by reference to said plat. --This being a portion of the identical property heretofore conveyed to John C. Scurry, M.D. and Ralph Brooks Scurry, M.D., by Deed of Lamar Kennedy dated August 23, 1972, which Deed is recorded in the RMC Office for Greenville County, S.C. in Deed Book 92 at Pg. 637. The property described in said Deed reflects said Tract No. 2 as containing 80.6 acres, more or less, but upon a re-survey of said property, same reflects 81.45 acres. The said mortgage to remain in full force and effect, and in all other respects unchanged as to the rights given therein to the holder of said mortgage.
