All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being known and designated as Lot No. 27 on Plat of Meadow Acres, Section 2, prepared by Jones Engineering Service and having, according to said plat, the following metes and bounds, to wit:

BEGINNING at an iron pin on the southeasterly side of Kennel Court at the joint front corner of Lots No. 26 and 27 and running thence along said Kennel Court, N. 45-15 E., 130 feet to an iron pin at the intersection of Kennel Court and Pollard Road; thence S. 89-45 E., 28.2 feet to an iron pin on Pollard Road; thence S. 44-45 E., 146 feet to an iron pin; thence S. 39-08 W., 151 feet to an iron pin; thence along the joint line of Lots No. 26 and 27, N. 44-45 W., 183 feet to the point of beginning.
