WHEREAS, the Mortgagor is well and truly indebted unto UNITED FEDERAL SAVINGS AND LOAN ASSOCIATION OF Fountain Inn, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by

reference, in the sum of Sixteen Thousand and 00/100-----

DOLLARS (\$ 16,000.00), with interest thereon from date at the rate of Eight per centum per annum, said principal and interest to be paid as therein stated, and

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does hereby grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of GREENVILLE, being known and designated as Lot 53 on a Plat of Parkwood, Section 1, prepared by C. O. Riddle, Surveyor, dated July, 1969, recorded in the R.M.C. Office for Greenville County in Plat Book 4-F, Page 22, and having, according to said Plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Eastern edge of Oak Park Drive, at the joint front corner of Lots 52 and 53 and running thence with the edge of Oak Park Drive, N. 29-50 W., 80 ft. to an iron pin at the joint front corner of Lots 53 and 54; thence with the joint line of Lots 53 and 54, N. 49-16 E., 136.3 ft. to an iron pin; thence S. 35-00 E., 128 ft. to an iron pin at the joint rear corner of Lots 52 and 53; thence with the joint line of Lots 52 and 53, S. 68-38 W., 147 ft. to an iron pin being the point of beginning.
