WHEREAS, the Mortgagor is well and truly indebted unto UNITED FEDERAL SAVINGS AND LOAN ASSOCIATION OF Fountain Inn, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of One Hundred Thousand and 00/100-----

DOLLARS (\$ 100,000.00___), with interest thereon from date at the rate of Nine & One-Half per centum per annum, said principal and interest to be paid as therein stated, and

All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of GREENVILLE, being known and designated as Lots 46, 47, 48, 50, 51, 52, 54; Lots 60 through 67; Lots 77, 84, 93, 97 and 102; Lots 121 through 133; and a portion of Lot 134, as shown on a Plat of HOLLY SPRINGS SUBDIVISION, SECTION NO. 2, prepared by Piedmont Engineers and Architects, dated November 19, 1972, and recorded in the R.M.C.
