TO ALL WHOM THESE PRESENTS MAY CONCERN: W. N. Leslie, Inc.

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto CAROLINA FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, Greenville, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of Seventy-One Thousand Four Hundred and No/100 ----- DOLLARS (\$71,400.00-----), with interest thereon as provided in said promissory note, said principal and interest to be paid as therein stated, and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purpose, and

WHEREAS, the unpaid balance of said debt or debts, if not sooner paid, shall be due and payable,

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the County of Greenville, State of South Carolina, and shown as Lot No. 62 on plat of Section II, Old Mill Estates, as recorded in the RMC Office for Greenville County, S.C., in Plat Book 4R, at Page 22, and having, according to said plat, the following courses, to-wit: BEGINNING at a point on the southeastern side of Eastwood Drive, joint front corner of Lots Nos. 62 and 63, and running thence with said Drive, N. 25-08 E. 80 feet to a point; thence, N. 75-49 E. 31.7 feet to a point on the edge of Eastwood Court; thence with said Court, S. 53-30 E. 165 feet to a point; thence, S. 27-03 W. 154.1 feet to a point; thence with the line of Lot No. 63, N. 39-32 W. 200 feet to a point, the point of beginning. ALSO, ALL that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the County of Greenville, State of S.C., being shown as Lot No. 63 on plat of Section II, Old Mill Estates, as recorded in the RMC Office for Greenville County, S.C., in Plat Book 4R, at Page 22, and having, according to said plat, the following courses, to-wit: BEGINNING at a point on the southeastern side of Eastwood Drive, joint front corner of Lots Nos. 63 and 62, and running thence with the common line of said lots, S. 39-32 E. 243.3 feet to a point; thence, S. 85-51 W. 190 feet to a point; thence, N. 9-22 W. 60.4 feet to a point; thence, N. 21-52 W. 130.9 feet to a point on the edge of Eastwood Drive, thence with said Drive, N. 86-09 E. 66.8 feet; thence, N. 59-33 E. 30.75 feet to the point of beginning.

The mortgagee agrees to release Lot No. 62 from the lien of this mortgage upon payment to it of the sum of \$35,900.00, said sum to be applied against the indebtedness which this mortgage secures. FURTHER, the Mortgagee agrees to release Lot No. 63 from the lien of this mortgage upon payment to it of the sum of \$35,500.00, said sum to be applied against the indebtedness which this mortgage secures.
