ALL that piece, parcel or lot of land situate, lying and being in the County of Greenville, State of South Carolina, being shown as Lot No. 3 on plat of Pinehurst Subdivision as recorded in the RMC Office for Greenville County, South Carolina, in Plat Book PP, at Page 39, and having, according to said plat, the following courses and distances, to-wit: BEGINNING at an iron pin on the western edge of Montis Drive, joint front corner of Lots Nos. 4 and 3, and running thence with the western edge of Montis Drive, S. 0-58 E. 90 feet to a point, joint front corner of Lots Nos. 3 and 2; thence with the common line of said lots, S. 89-02 W. 289.1 feet to an iron pin; thence, N. 19-34 W. 95 feet to an iron pin; thence with the common line of Lots Nos. 4 and 3, N. 89-02 E. 320 feet to an iron pin on the western edge of Montis Drive, the point of beginning.

This mortgage is junior in lien to that given by the Mortgagors to First Federal Savings & Loan Association on October 15, 1973, encumbering the above-described property, as recorded in the RMC Office for Greenville County, S.C., in REM Book 1293, at Page 264, on which there is a present balance owing of \$21,985.24.
