conditioned for the payment in lawful money of the United States of America of the full and just sum of Three Thousand Six Hundred Seventy Two Dollars and 00/100

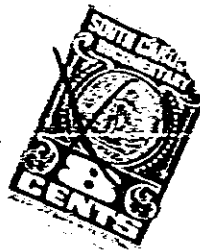
