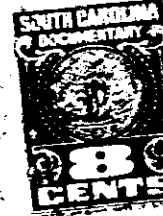
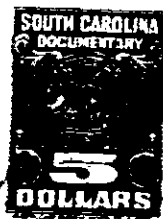
WHEREAS, the unpaid balance of said debt or debts, if not sooner paid, shall be due and payable.

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does hereby grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, near the Town of Simpsonville, being known and designated as Lot No. 25 on a Plat of Meadow Acres prepared by Jones Engineering Service dated May 19, 1972 and having, according to said plat, having the following metes and bounds, to wit:

BEGINNING at an iron pin on the northwestern side of Kennel Road at the joint front corner of Lots No. 24 and 25; thence along the edge of said Kennel Road, N. 45-15 E., 125 feet to an iron pin; thence S. 44-45 E., 196.5 feet to an iron pin at the joint rear corner of Lots No. 26 and 25; thence S. 39-08 W., 125.6 feet to an iron pin; thence N. 44-45 W., 211.3 feet to an iron pin on the northwestern side of Kennel Road, being the point of beginning.
