## MORTGAGE

TO ALL WHOM THESE PRESENTS MAY CONCERN: John J. DiFresco and Chrystine

W. DiFresco

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of

Thirty-two thousand four hundred twenty-four and 79/100 --- DOLLARS

(\$ 32,424.79 ), as evidenced by the Mortgagor's note of even date, bearing interest as stated in said note, and payable as therein stated or as modified by mutual agreement, in writing, the final maturity of which is 27 years after the date hereof, unless extended by mutual consent, the terms of said note and any agreement modifying it are incorporated herein by reference; and

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

\*All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville,

Being shown and designated as Lot 19, Section One of Pelham Woods, plat of which is duly recorded in the R.M.C. Office for Greenville County in Plat Book 4F at Page 33, reference to said plat being hereby craved for a more particular description.

Beginning at an iron pin on the southwesterly side of Maplewood Drive front joint corner of lots 19 and 20 and running thence with the common line of said lots S.38-50 W. 175.70 feet to an iron pin, rear joint corner of lots 19 and 20; thence N.56-42 W. 152.01 feet to an iron pin rear joint corner of lots 19 and 18; thence N.56-05 E. 212.94 feet to an iron pin on Maplewood Drive; thence with said drive S.42-35 E. 89.62 feet to the beginning point.



Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and any other equipment or fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.
