NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bergained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, city of Greenville, shown as Lots Nos. 18 and 18A, Section A, BUIST CIRCLE, on a plat recorded in the R. M. C. Office for Greenville County, South Carolina, in Plat Book C, Page 10, and having, according to a plat recorded in said R. M. C. Office in Plat Book HH, Page 17, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northern side of Mountain View Avenue, 250 feet in a westerly direction from the northwest intersection of Mountain View Avenue and Townes Street, and running thence N 9-12 E 232.2 feet to an iron pin on the southern side of Orange Street; thence with the southern side of Orange Street, N 72-19 W 100.6 feet to an iron pin in the joint rear corner of Lots Nos. 17 and 18; thence with the joint line of said lots, S 9-26 W 246 feet to an iron pin on the northern side of Mountain View Avenue; thence with the northern side of Mountain View Avenue, S 80-15 E 100 feet to the point of beginning.
