with interest thereon from maturity at the rate of seven (7%) per centum per annum, to be paid on demand

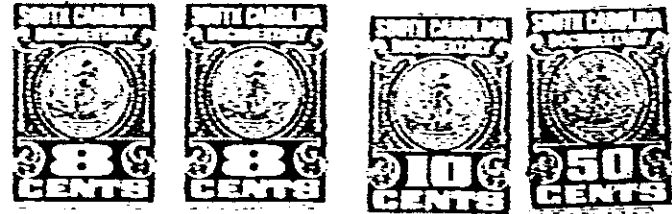

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars \$3.00 to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being known and designated as a portion of lot No. 3 on a plat of BRYSON ACRES SUBDIVISION, as shown by Plat thereof recorded in Plat Book 000 at page 128, and having according to a recent survey prepared by Carolina Surveying Co., dated December 6, 1973, the following metes and bounds, to wit:

BEGINNING at an iron pin on the Southwesterly side of Poplar Drive and running thence with the line of Lot No. 5, S. 25-0 W., 208.5 feet to an iron pin; thence S. 71-18 W., 40 feet to an iron pin; thence a new line, N. 15-16 W., 250.4 feet to an iron pin on the Southwesterly side of Poplar Drive; thence with the edge of Poplar Drive, N. 71-40 E., 69.9 feet to an iron pin; thence continuing with the edge of said Poplar Drive, S. 63-49 E., 140 feet to the beginning corner.
