

EXHIBIT C
RESOLUTION
(AUTHORIZING BONDED INDEBTEDNESS)

BE IT RESOLVED:

THAT Westville Baptist Church of Greenville, South Carolina, Greenville, S. C. (hereinafter referred to as the Issuer) issue and sell its Special Revenue Bonds of serial maturity in the total aggregate amount of \$25,000.00 bearing interest at the rate of 7½ per cent per annum compounded semi-annually for the purpose of financing the completion of construction and furnishing of the sanctuary and that a portion of the revenue of the Issuer be appropriated and irrevocably assigned and pledged to pay the principal and all interest as the same shall come due, which sums shall not exceed the following:

\$ 157.00 per month beginning December 1, 1973 through 12 years 9 months,
then \$1760.00 per month beginning August 1, 1986 through 1 year 3 months
(or until all bonds are paid)

THAT the Deacons of the Issuer be instructed to select and approve, (in consultation with Security Church Finance, Inc.) the Paying Agent Bank, the dates of the campaign, the date the bonds shall begin earning interest, the amount and type bond to be placed upon the Treasurer, and to enter into an agreement with Security Church Finance, Inc. for the preparation of this bond issue, including the type program and fee.

THAT all the necessary instruments and documents pertaining to this bond issue including but not limited to:

- The Agreement with Security Church Finance, Inc.
- The Resolution describing the terms and conditions of the issue
- The Bonds

shall be on forms furnished or approved by Security Church Finance, Inc. and approved and completed by an attorney-at-law retained by the Issuer and shall be signed for and on behalf of the Issuer by the following designated individuals, or their successors in office:
