TO ALL WHOM THESE PRESENTS MAY CONCERN: Thomas F. Welborn and Ruth M. Welborn

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of Twelve thousand and no/100ths----- DOLLARS

(\$12,000.00), as evidenced by the Mortgagor's note of even date, bearing interest as stated in said note, and payable as therein stated or as modified by mutual agreement, in writing, the final maturity of which is 15 years after the date hereof, unless extended by mutual consent, the terms of said note and any agreement modifying it are incorporated herein by reference; and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced or readvanced to or for the Mortgagor's account, including advances made by the Mortgagee on other or no security:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the southeastern side of Westcliffe Way, near the City of Greenville and being shown and designated as Lot 106 on plat of Westcliffe, prepared by Piedmont Engineers and Architects dated December 11, 1963, recorded in the RMC Office for Greenville County in Plat Book YY at Pages 168 and 169 and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southeastern side of Westcliffe Way at the joint front corner of Lots 105 and 106 and running thence along and with the joint property line of said two Lots, S 9-39 E 180 feet to an iron pin; thence S 81-00 W 120 feet to an iron pin at the joint rear corner of Lots 106 and 107 as shown on the aforesaid plat; thence running along and with the joint property line of said last two mentioned Lots, N 9-39 E 180 feet to an iron pin on the southeastern side of Westcliffe Way; thence running along and with the southeastern side of Westcliffe Way, N 81-00 E 120 feet to the beginning point.

The above-described property was conveyed to the Mortgagors herein by deed to be recorded forthwith.
