TO ALL WHOM THESE PRESENTS MAY CONCERN:

James F. McCoy (hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of Twenty-six Thousand and no/100-----DOLLARS

(\$ 26,000.00), as evidenced by the Mortgagor's note of even date, bearing interest as stated in said note, and payable as therein stated or as modified by mutual agreement, in writing, the final maturity of which is 25 years after the date hereof, unless extended by mutual consent, the terms of said note and any agreement modifying it are incorporated herein by reference; and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced or readvanced to or for the Mortgagor's account, including advances made by the Mortgagee on other or no security:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, situate on S. C. Highway # 23-106, being shown as lot no. 27 on a plat of Heathwilde Subdivision dated May 23, 1968, prepared by Campbell and Clarkson, recorded in Plat Book WW at Page 18 in the R.M.C. Office for Greenville County and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northeastern side of S. C. Highway # 23-106 at the joint front corner of lot 20 and lot 27 and running thence with lot 20 N. 30-16 E. 225 feet to an iron pin at the joint rear corner of lot 26 and lot 27; thence with lot 26 S. 59-44 E. 225 feet to an iron pin at the joint rear corner of lot 27 and lot 28; thence with lot 28 S. 30-16 W. 225 feet to an iron pin on S. C. Highway #23-106; thence with said Highway, N. 59-44 W. 225 feet to the point of beginning.

This is the same property conveyed to the mortgagor by deed recorded in Deed Book 873 at Page 306 in the R.M.C. Office for Greenville County.
