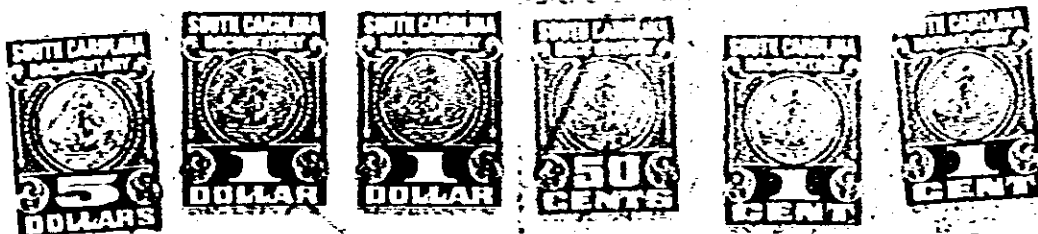

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced or readvanced to or for the Mortgagor's account, including advances made by the Mortgagee on other or no security:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

*All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being known and described as Lot 55 as shown on plat of subdivision known as Parkdale, according to survey thereof made by Dalton and Neves, Engineers in July, 1960, recorded in the R.M.C. Office for Greenville County in Plat Book 'RR' at page 55 and having according to said plat the following metes and bounds, to-wit:

Beginning at an iron pin on the western side of Woodridge Drive at the joint front corner of Lots #s 55 and 56 and running thence with the line of Lot #56, S. 86-38 W. 160 feet to an iron pin in the rear line of Lot 61; thence with the rear line of Lots #s 61 and 62, S. 3-22 E. 90 feet to an iron pin at the joint rear corner of Lots #s 54 and 55; thence with the line of Lot #54 N. 86-38 E. 160 feet to an iron pin on the western side of Woodridge Drive; thence with the western side of Woodridge N. 3-22 W. 90 feet to the point of beginning.



Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and any other equipment or fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.
