KNOW ALL MEN BY THESE PRESENTS:

That for and in consideration of the sum of Ten Dollars (\$10.00), cash in hand paid, and other good and valuable considerations, the receipt of all of which is hereby acknowledged, the undersigned INVESTORS ACCEPTANCE CORP. does hereby grant, bargain, sell, assign, transfer and set over unto AVCO DELTA CORP. OF PA, all that certain deed of trust executed by Lloyd C. Whitworth & Faye Whitworth, dated the 23rd day of Oct., 1968, and recorded in the office of the Clerk of the County Court of Greenville S.C., on the 1 day of Nov, 1968, in Trust Deed Book No. 1109 at page 127, and conveying certain real property therein described, to William H.
