351.3 feet to an iron pin; thence along the back line of two one acre tracts N. 53-07 E. 248 feet to an iron pin; thence along a line of a one acre tract N. 35-34 W. 351.3 feet to a point in the center of said road; thence along the center of said road N. 52-32 E. 100 feet to a point; thence continuing along the center of said road N. 58-52 E. 146.7 feet to a point; thence continuing along said road N. 66-57 E. 168 feet to the beginning corner and containing 22.83 acres, more or less.
