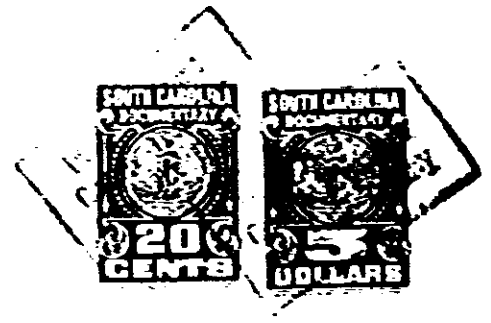
Thirteen Thousand and No/100----- DOLLARS
