All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being shown as Lot No. 22 on plat of Annissa Acres, recorded in Plat Book 4R at page 63 in the RMC Office for Greenville County, and having the following metes and bounds:

Beginning at an iron pin on the southern side of Emily Lane at the joint front corner of Lots 21 and 22, thence with the joint line of said lots, S 7-46 E 240.9 feet to an iron pin; thence S 64-59 W 110 feet to an iron pin at the joint rear corner of Lots 22 and 23; thence with joint line of said lots, N 7-46 W 273.5 feet to an iron pin on the southern side of Emily Lane; thence with said Lane, N 82-14 E 105 feet to the beginning corner.
