TO ALL WHOM THESE PRESENTS MAY CONCERN:

Franklin Enterprises, Inc. (hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of Forty-nine Thousand Six Hundred and no/100 ----- DOLLARS

(\$ 49,600.00 ), as evidenced by the Mortgagor's note of even date, bearing interest as stated in said note, and payable as therein stated or as modified by mutual agreement, in writing, the final maturity of which is 29 years after the date hereof, unless extended by mutual consent, the terms of said note and any agreement modifying it are incorporated herein by reference; and

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, situate on the northwestern side of Middle Brook Road in the County of Greenville, State of South Carolina, being shown as lot no. 304 on a plat of Sugarcreek Subdivision Map No. 1, Section I, dated December 11, 1973, prepared by C. O. Riddle, recorded in Plat Book 5-D at Page 18 in the R.M.C. Office for Greenville County and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northwestern side of Middle Brook Road at the joint front corner of lot 303 and lot 304 and running thence with lot 303 N. 49-15 E. 170 feet to an iron pin at the joint rear corner of lot 303 and lot 304; thence with lot 309 and lot 310 S. 40-45 W. 128.44 feet to an iron pin at the joint rear corner of lots 304 and 305; thence with lot 305 S. 49-15 E. 170 feet to an iron pin on Middle Brook Road; thence with said Road N. 40-45 E. 128.44 feet to an iron pin, the point of beginning.



Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and any other equipment or fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.
