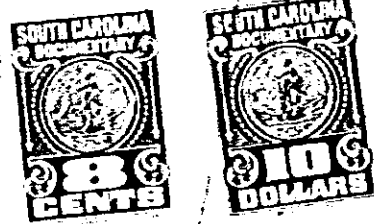
(\$ 25,150.32), as evidenced by the Mortgagor's note of even date, bearing interest as stated in said note, and payable as therein stated or as modified by mutual agreement, in writing, the final maturity of which is twenty-five years after the date hereof, unless extended by mutual consent, the terms of said note and any agreement modifying it are incorporated herein by reference; and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced or readvanced to or for the Mortgagor's account, including advances made by the Mortgagee on other or no security:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Town of Mauldin, situate on the southeastern side of Old Hickory Point, and being shown and designated as Lot 31 of a subdivision known as Forrester Woods, Section I, as shown on plat thereof prepared by R. B. Bruce, R.L.S., dated March 14, 1972, and recorded in the R.M.C. Office for Greenville County in Plat Book 4N at Page 78, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southeastern side of Old Hickory Point at the joint front corner of Lots 28 and 31; thence running along Old Hickory Point, N. 27-36 E., 110 feet to an iron pin at the joint front corner of Lots 31 and 32; thence along the common line of Lots 31 and 32, S. 62-24 E. 160 feet to an iron pin at the joint corner of Lots 31, 32, 33 and 30; thence along the common line of Lots 30 and 31, S. 27-36 W. 110 feet to an iron pin at the joint corner of Lots 31, 30, 28 and 29; thence along the common line of Lots 28 and 31, N. 62-24 W., 160 feet to the point and place of beginning.
