"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in the City of Greenville, on the southwest side of Blythwood Drive, being shown as Lot No. 18 on a plat of property of J. Louis Coward, made by E. C. Cahaly, Surveyor, August 16, 1952, and is further shown as a portion of Lot No. 17 and 18 on plat of University Circle, made by Piedmont Engineering Service, May, 1948, recorded in the R.M.C.
