TO ALL WHOM THESE PRESENTS MAY CONCERN: we, David L. Johnson and Roma F. Johnson

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

All that certain piece, parcel or lot of land, with all improvements thereon, or to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Chick Springs Township, about 1½ miles South from Greer, on the Eastern side of Grand Teton Drive and being shown and designated as all of Lot No. Six (6) on plat of property entitled "Teton Forest", Section 1 made by John A.
