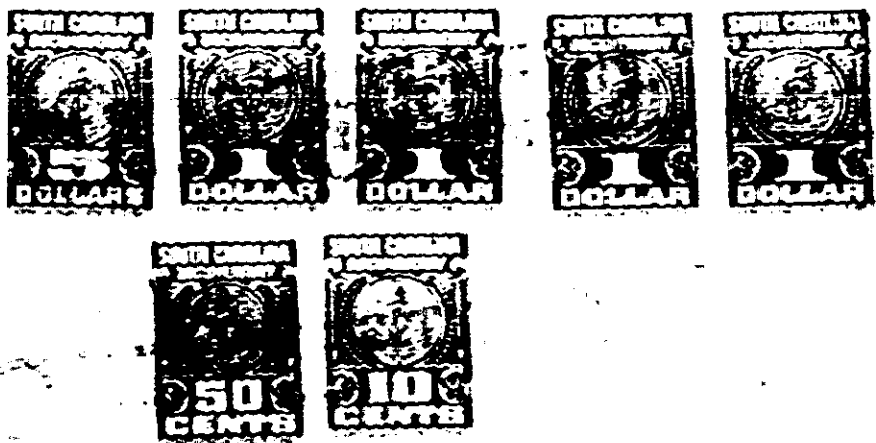
WHEREAS:

whereof is hereby acknowledged, has granted, bargained, sold, assigned, and released, and by these presents does
