TO ALL WHOM THESE PRESENTS MAY CONCERN:

CHARLES BRUCE MCNIEL AND MELANIE T. MCNIEL
(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto CAROLINA FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, Greenville, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of Thirty-Seven Thousand Five Hundred and 00/100----

DOLLARS (\$ 37,500.00), with interest thereon as provided in said promissory note, said principal and interest to be paid as therein stated, and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purpose, and

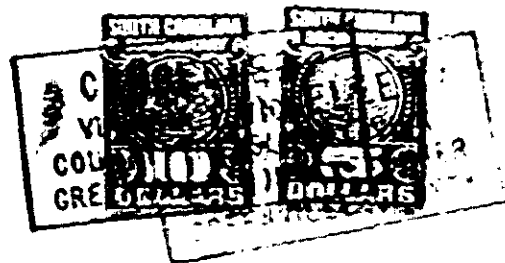
WHEREAS, the unpaid balance of said debt or debts, if not sooner paid, shall be due and payable.

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, near the town of Simpsonville, being known and designated as Lot No. 23, on a plat of Rollingwood, prepared by C.O. Riddle, Surveyor, dated February, 1963, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the westerly edge of Green Hill Drive, joint front corner of Lots 23 and 24, and running thence along the line of Lot 24, N. 66-30 W. 339.3 feet to an iron pin; thence along the line of Lot 22, N. 27-40 E. 318.3 feet to an iron pin on the southerly edge of Green Hill Drive; thence following the curve of Green Hill Drive as follows: South 81-30 E. 110.6 feet, S. 64-49 E. 69.3 feet, S. 41 E. 80 feet, S. 15-12 E. 80 feet, S. 10-36 W. 80 feet, and S. 23-30 W. 169.2 feet to the point of the beginning.

It is understood and agreed that this Mortgage cover all improvements situate upon the property herein described.
