WHEREAS:

JAMES WALTER BYERS----- of Greenville, South Carolina-----, hereinafter called the Mortgagor, is indebted to

C. DOUGLAS WILSON & CO.-----, a corporation organized and existing under the laws of Greenville, South Carolina-----, hereinafter called Mortgagee, as evidenced by a certain promissory note of even date herewith, the terms of which are incorporated herein by reference, in the principal sum of Fourteen Thousand One Hundred and No/100----- Dollars (\$14,100.00-----), with interest from date at the rate of nine----- per centum (9---- %) per annum until paid, said principal and interest being payable at the office of C. Douglas Wilson & Co.----- in Greenville, South Carolina-----, or at such other place as the holder of the note may designate in writing delivered or mailed to the Mortgagor, in monthly installments of One Hundred Thirteen and 51/100----- Dollars (\$113.51-----), commencing on the first day of September-----, 1974, and continuing on the first day of each month thereafter until the principal and interest are fully paid, except that the final payment of principal and interest, if not sooner paid, shall be due and payable on the first day of August, 2004.

Now, KNOW ALL MEN, that Mortgagor, in consideration of the aforesaid debt and for better securing the payment thereof to the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, assigned, and released, and by these presents does grant, bargain, sell, assign, and release unto the Mortgagee, its successors and assigns, the following-described property situated in the county of Greenville-----, State of South Carolina;

ALL that certain piece, parcel or lot of land, situate, lying and being in the State of South Carolina, County of Greenville, in the City of Greenville, on the southern side of E. North Street Extension (formerly known as Spartanburg Road) and being a portion of Lot No. 14, according to a plat prepared by O. H. Jones, Architect and Engineer, September 17, 1913 and copied by W. D. Neves, April 19, 1920 and recorded in the R.M.C. Office for Greenville County, South Carolina in Plat Book "E" at Pages 251-252; reference to said plat is craved for metes and bounds.
