called Mortgagee, as evidenced by a certain promissory note of even date herewith, the terms of which are incor-  
porated herein by reference, in the principal sum of Thirty-Four Thousand Eight Hundred  
Seventy-Five and No/100-----Dollars (\$34,875.00--), with interest from date at the rate of  
eight & three-fourths per centum (8 3/4%) per annum until paid, said principal and interest being payable  
at the office of Carolina National Mortgage Investment Co., Inc.  
in Charleston, South Carolina , or at such other place as the holder of the note may  
designate in writing delivered or mailed to the Mortgagor, in monthly installments of Two Hundred Seventy-four  
and 47/100-----Dollars (\$ 274.47---), commencing on the first day of  
September , 19 74, and continuing on the first day of each month thereafter until the principal and  
interest are fully paid, except that the final payment of principal and interest, if not sooner paid, shall be due and  
payable on the first day of August, 2004 , .

Now, KNOW ALL MEN, that Mortgagor, in consideration of the aforesaid debt and for better securing the  
payment thereof to the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3) to the Mortgagor  
in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt  
whereof is hereby acknowledged, has granted, bargained, sold, assigned, and released, and by these presents does  
grant, bargain, sell, assign, and release unto the Mortgagee, its successors and assigns, the following-described  
property situated in the county of  
State of South Carolina;

ALL that certain piece, parcel or lot of land, with all improvements thereon,  
situate, lying and being in the County of Greenville, State of South Carolina,  
being known and designated as Lot No. 217, Charter Oak Drive, Peppertree  
Subdivision, Section No. 2, as shown on a plat of Peppertree, recorded in  
Plat Book 4X at Page 3, and having, according to said plat, the following  
metes and bounds, to-wit:

BEGINNING at an iron pin located on the northwestern side of the right-of-  
way of Charter Oak Drive, a joint corner of Lot Nos. 218 and 217; thence
