

SECURITY DEED FROM WALTER KASSUBA REALTY CORPORATION, A WISCONSIN CORPORATION, TO JACK R. COURSHON AS NOMINEE OF THE TRUSTEES OF MEDIAN MORTGAGE INVESTORS, A MASSACHUSETTS BUSINESS TRUST, DATED MARCH 20, 1973, FILED FOR RECORD APRIL 19, 1973 IN DEED BOOK 1414, PAGE 73, IN THE OFFICE OF THE CLERK OF THE SUPERIOR COURT OF COBB COUNTY, GEORGIA.
