BEING shown as Lot No. 7 of Block "D" on a Plat of Fair Heights, made by R. E. Dalton, Engineer, October, 1924, recorded in the R.M.C. Office for Greenville County, S. C., in Plat Book F, Pages 256 and 257, and having, according to said Plat, the following metes and bounds, to-wit:
