All that certain piece, parcel, or lot of land, with all improvements thereon, or hereafter to be constructed thereon, situate, bing and being in the State of South Carolina, County of Greenville, on the northeastern side of Charing Cross Road, shown as Lot 13 on a plat of Section 3, Brookwood Forest, recorded in the R. M. C. Office for Greenville County in Plat Book BBB, at Page 156, and being further described as follows:
