TALL that certain piece, parcet or let of lard, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, known and designated as Lot No. 17 on plat of Richmond Hills, Section Five, made by R. B. Bruce, R.L.S., dated November, 1967, recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book WWW at Page 38, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on Konnarock Circle at the joint front corner of Lots No. 16 and 17 and running thence with the joint line of said lots N 62-24 W 150 feet to an iron pin; thence N 27-36 E 100 feet to an iron pin at the joint rear corner of Lots 17 and 18; thence S 62-24 E 150 feet to iron pin on Konnarock Circle; thence with said circle S 27-36 W 100 feet to an iron pin at point of beginning.
