Two Hundred Ninety-Six and 91/100-----(\$ 296.91) Dollars each on the first day of each month hereafter, in advance, until the principal sum with interest has been paid in full, such payments to be applied first to the payment of interest, computed monthly on unpaid principal balances, and then to the payment of principal with the last payment, if not sooner paid, to be due and payable.

That the Mortgagor, in consideration of said debt and to secure the payment thereof and any further sums which may be advanced by the Mortgagoe to the Mortgagor's account, and also in consideration of the sum of Three Dollars (53.00) to the Mortgagor in hand well and truly paid by the Mortgagoe at and before the sealing of these presents, the receipt whereof is bereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell and release unto the Mortgagoe, its successors and assigns, the following described real estate:

All that certain piece, parcel, or lot of land, with all improvements thereon, or bereafter to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being known and designated as Lot 28 of a subdivision known as Edwards Forest Heights as shown by plat thereof prepared by Jones Engineering Service, February 1967, recorded in the R. M. C. Office for Greenville County in Plat Book OOO at Page 87 and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northeastern side of Rollingwood Drive, j oint front corner of Lots 28 and 29 and running thence along the joint line of said lots, N. 57-08 E. 110 feet to an iron pin at the joint corner of Lots 28 and 37; thence along the line of Lot 37, S. 85-37 E. 112 feet to an iron pin on the western side of Holly Road; thence along the western side of Holly Road, S. 4-23 W. 116.5 feet to an iron pin; thence continuing along the western side and northwestern side of Holly Road, following the curvature thereof, chords being S. 13-23 W. 50 feet and S. 31-23 W. 50 feet to an iron pin; thence following the curvature of Holly Road as it intersects with Rollingwood Drive, the chord being N. 88-30 W. 49.2 feet to an iron pin on the northeastern side of Rollingwood Drive; thence along the northeastern side of Rollingwood Drive, N. 35-22 W. 187.7 feet to the beginning corner; being the same conveyed to us by George William Morris and Amandra S.
