TO ALL WHOM THESE PRESENTS MAY CONCERN: SANDRA D. HADDEN

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of Twenty-One Thousand Two Hundred and no/100ths (\$21, 200. 00)-----DOLLARS

(\$21, 200. 00-----), as evidenced by the Mortgagor's note of even date, bearing interest as stated in said note, and payable as therein stated or as modified by mutual agreement, in writing, the final maturity of which is twenty (20)-- years after the date hereof, unless extended by mutual consent, the terms of said note and any agreement modifying it are incorporated herein by reference; and

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the western side of White Horse Road, shown as Lot 29 on Plat of Parksdale, recorded in Plat Book RR at page 55, in the R. M. C. Office for Greenville County, and being further described, according to said plat as follows:

BEGINNING at an iron pin on the western side of White Horse Road, joint front corner of lots 28 and 29, and running thence along the line of lot 28, S. 86-38 W. 160 feet to iron pin; thence along line of lot 46, N. 3-22 W. 97 feet to iron pin, corner of lot 30; thence along line of lot 30, N. 86-38 E. 160 feet to iron pin on the western side of White Horse Road; thence along the western side of White Horse Road, S. 3-22 E. 97 feet to the beginning corner.

This property of record is sold subject to the reservations, easements, rights of way, building lines and restrictive covenants as shown on said plat recorded in Plat Book 658, at Page 67, R. M. C. Office for Greenville County.
