



MORTGAGE

THIS MORTGAGE is made this 23th day of August, 1974, between the Mortgagor, William B. Freeman and Susan M. Freeman

(herein "Borrower") and the Mortgagee, Home Building and Loan Association, a corporation organized and existing under the laws of South Carolina, whose address is 208 East First Avenue, Easley, South Carolina (herein "Lender").

WHEREAS, Borrower is indebted to Lender in the principal sum of Twenty Nine Thousand Two Hundred & 00/100 (\$29,200.00) Dollars, which indebtedness is evidenced by Borrower's note of even date herewith (herein "Note"), providing for monthly installments of principal and interest, with the balance of the indebtedness, if not sooner paid, due and payable on

To SECURE to Lender (a) the repayment of the indebtedness evidenced by the Note, with interest thereon, the payment of all other sums, with interest thereon, advanced in accordance herewith to protect the security of this Mortgage, and the performance of the covenants and agreements of Borrower herein contained, and (b) the repayment of any future advances, with interest thereon, made to Borrower by Lender pursuant to paragraph 21 hereof (herein "Future Advances"), Borrower does hereby mortgage, grant and convey to Lender and Lender's successors and assigns the following described property located in the County of Greenville, State of South Carolina:

"ALL THAT certain piece, parcel or lot of land in the County of Greenville, State of South Carolina, being shown as Lot No. 85 on plat entitled "Addition to Del Norte Estates, Section IV" recorded in Plat Book 4-N at page 10 in the RMC office for Greenville County and having according to said plat the following metes and bounds:

BEGINNING at an iron pin on the eastern side of Del Norte Road at the joint front corner of Lot No. 84 and running thence with the line of Lot No. 84 N 66-24 E 140 feet to an iron pin; thence South 23-36 East 95 feet to an iron pin at the rear corner of Lot 86; thence with the line of Lot X0. 86 South 66-24 West 140 feet to an iron pin on the eastern side of Del Norte Road; thence with the eastern side of Del Norte Road N 23-36 West 95 feet to the BEGINNING corner."

This is the identical property conveyed to William B. Freeman and Susan M. Freeman by Willard M. LeGette and Lynnette S. LeGette by deed dated , 1974, and recorded in Book of Deeds at page in the office of the RMC for Greenville County, South Carolina.



To HAVE AND TO HOLD unto Lender and Lender's successors and assigns, forever, together with all the improvements now or hereafter erected on the property, and all easements, rights, appurtenances, rents, royalties, mineral, oil and gas rights and profits, water, water rights, and water stock, and all fixtures now or hereafter attached to the property, all of which, including replacements and additions thereto, shall be deemed to be and remain a part of the property covered by this Mortgage; and all of the foregoing, together with said property (or the leasehold estate in the event this Mortgage is on a leasehold) are herein referred to as the "Property".

Borrower covenants that Borrower is lawfully seised of the estate hereby conveyed and has the right to mortgage, grant and convey the Property, that the Property is unencumbered, and that Borrower will warrant and defend generally the title to the Property against all claims and demands, subject to any easements and restrictions listed in a schedule of exceptions to coverage in any title insurance policy insuring Lender's interest in the Property.

UNIFORM COVENANTS. Borrower and Lender covenant and agree as follows:

1. Payment of Principal and Interest. Borrower shall promptly pay when due the principal of and interest on the indebtedness evidenced by the Note, prepayment and late charges as provided in the Note, and the principal of and interest on any Future Advances secured by this Mortgage.
