And said mortgagor agrees to keep the building and nepagorements now standing or repeated on tool apartics. fixtures and appurtenances now or hereafter in or attached to said buildings or response at insured against loss or damage by fire and such other hazards as the mortgager may from time to time require, all such insurance to be in forms, in companies and in sums (not less than sufficient to avoid any claim on the part of the insurers for co-insurance) satisfactory to the mortgager; that all insurance policies shall be held by and shall be for the height of and first payable in case of loss to the mortgager, and that at least fifteen days before the expiration of each such policy, a new and sufficient policy to take the place of the one so expiring shall be delivered to the nortgager.
