MORTGAGE OF REAL ESTATE

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaic debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of GREENVILLE, Fairview Township, being known and designated as Lots 5 and 6 on a Plat of Property of Mary E. Leake Estate, which Plat is recorded in the R.M.C. Office for Greenville County in Plat Book 5-D, Page 22, and having, according to said Plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Southern edge of Bryson Road, joint front corners of Lots 4 and 5 and running thence N. 56-41 E., 100 ft. to an iron pin, joint front corners of Lots 5 and 6; thence continuing N. 56-41 E., 100 ft. to an iron pin, joint front corners of Lots 6 and 7; thence S. 33-19 E., 410.3 ft. to an iron pin; thence S. 51-32 W., 100.4 ft. to an iron pin; thence continuing S. 51-32 W., 100.4 ft. to an iron pin; thence N. 33-19 W., 428.3 ft. to an iron pin at the point of beginning.
