WHEREAS, we, Charles W. Scott and Evelyn A. Scott

(hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being known and designated as LOT No. 17 Addition to Section II, Westcliff Subdivision as shown on a plat thereof prepared by Piedmont Engineering Service and Architects dated April 3, 1970 and recorded in the RMC Office for Greenville County in Plat Book 4-F, at page 32 and having, according to said plat, the following metes and bounds:

BEGINNING at an iron pin on Saluda Lake Road at the joint front corner of Lots 17 and 18 and running thence along the joint line of said lots, North 66-21 West 193.3 feet to an iron pin; running thence South 66-43 West 267 feet to an iron pin; running thence South 68-42 East 397.5 feet to an iron pin on Saluda Lake Road; running thence along Saluda Lake Road, North 17-10 East 30.2 feet to an iron pin; thence continuing with Saluda Lake Road, North 16-39 East 149.8 feet to the beginning corner.
